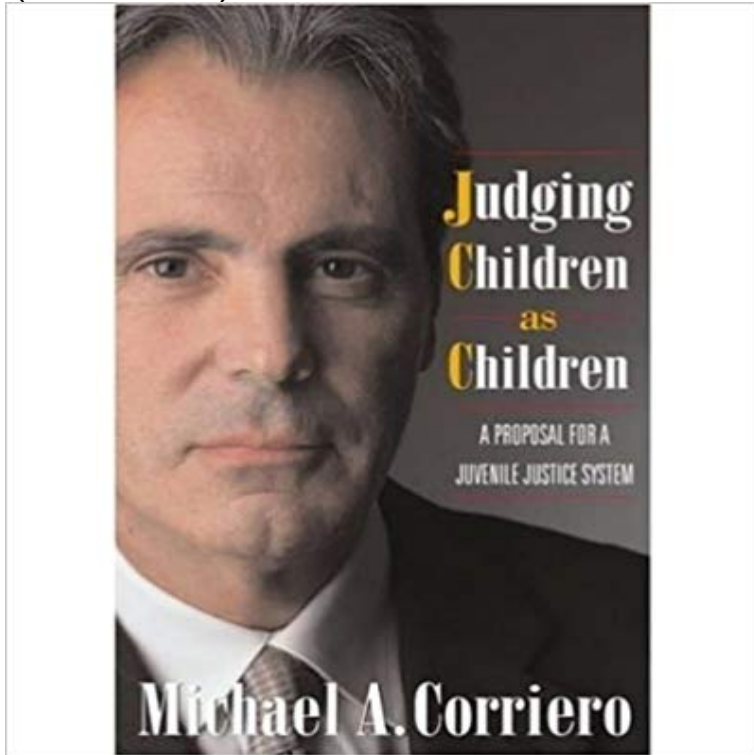


## Judging Children as Children: A Proposal for a Juvenile Justice System (Hardback) - Common
