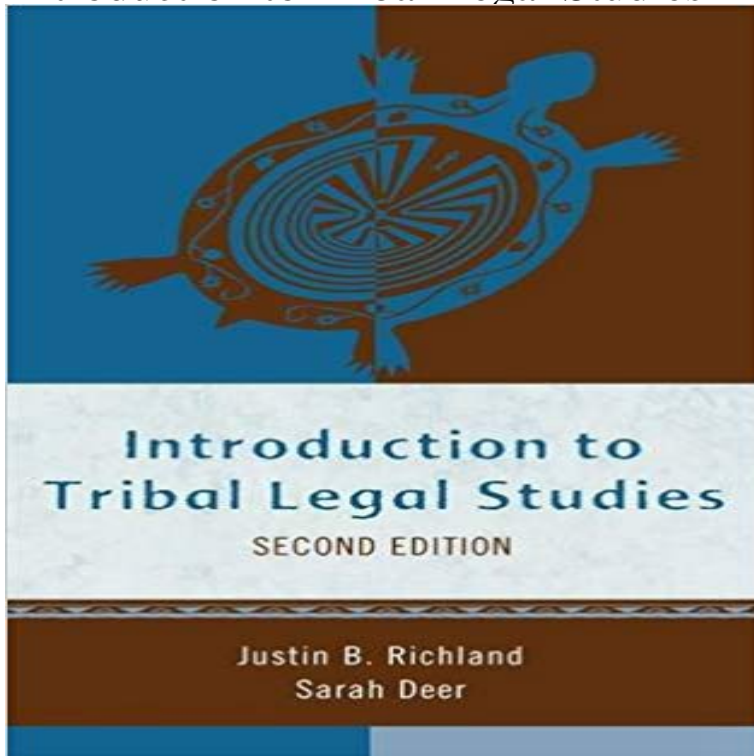


## Introduction to Tribal Legal Studies
