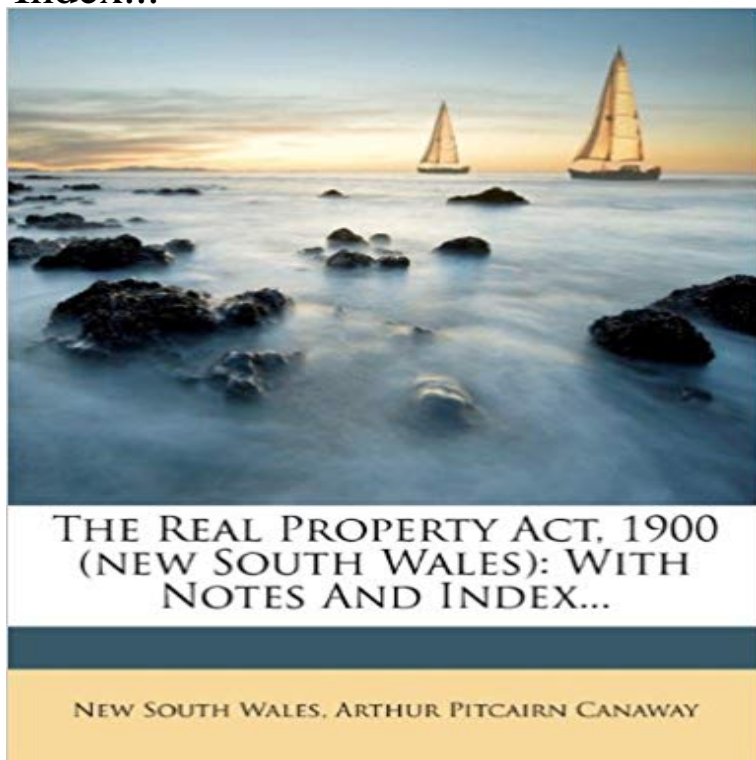


## The Real Property Act, 1900 (new South Wales): With Notes And Index...
